### **STEP 1:** GOALS

Develop and communicate goals for implementing a one-to-one technology initiative in your district.

#### **STEP 3: BUDGETING**



Develop a budget for both one-time and recurring expenses.

#### **STEP 4: PURCHASING**



Select and order one-to-one devices as well as other technological needs.

# **STEP 6:**COMMUNICATION



Develop, adopt, and communicate district policies related to your one-to-one initiative.
